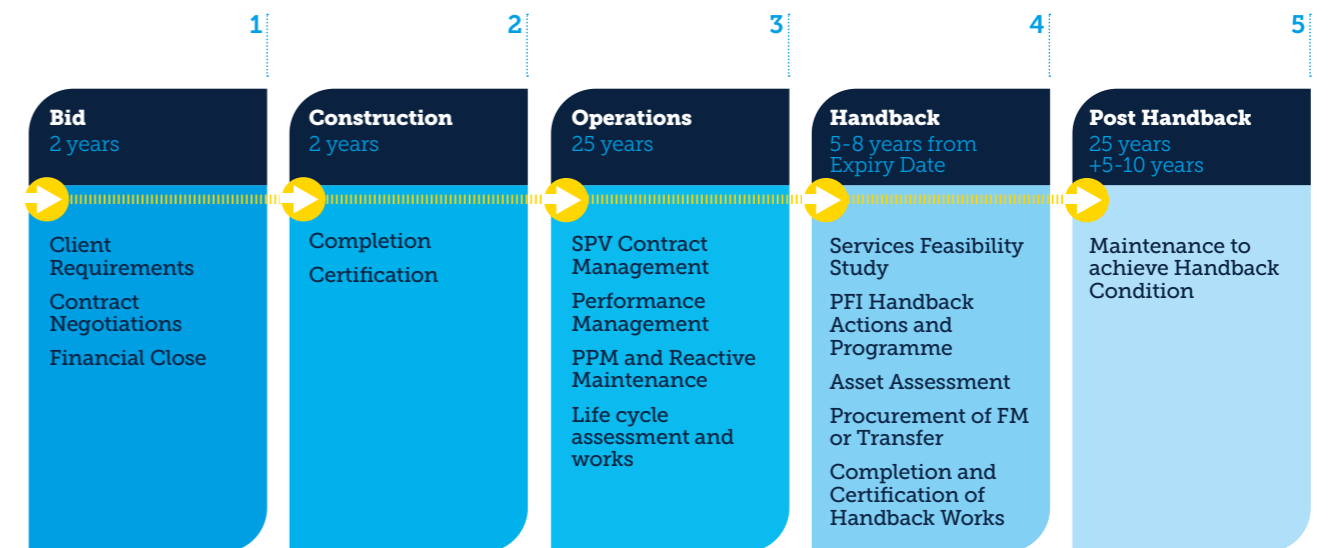


Introduction

Our Service

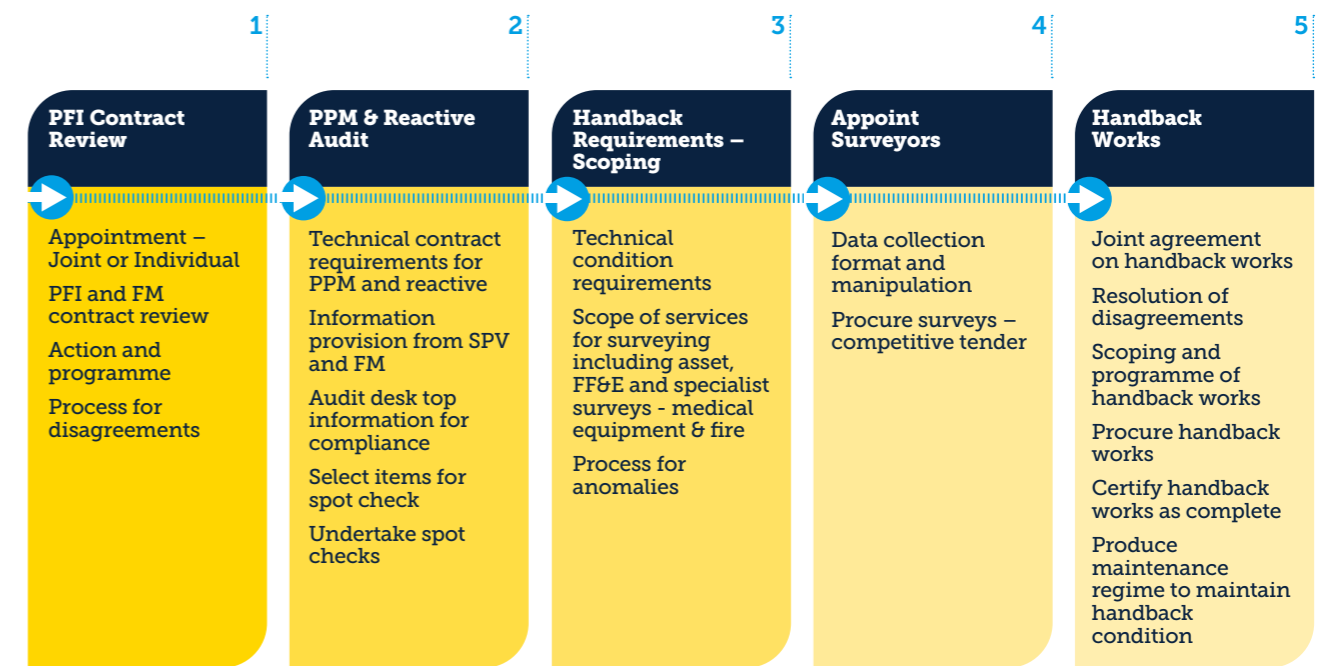

The handback process will require all the parties involved to consider and agree the status the assets need to achieve at handback and how the building, plant and equipment will be maintained and repaired once the PFI contract has finished.

In addition the NHS Trust client will need to consider the implications and opportunities of the on-going facilities management service.

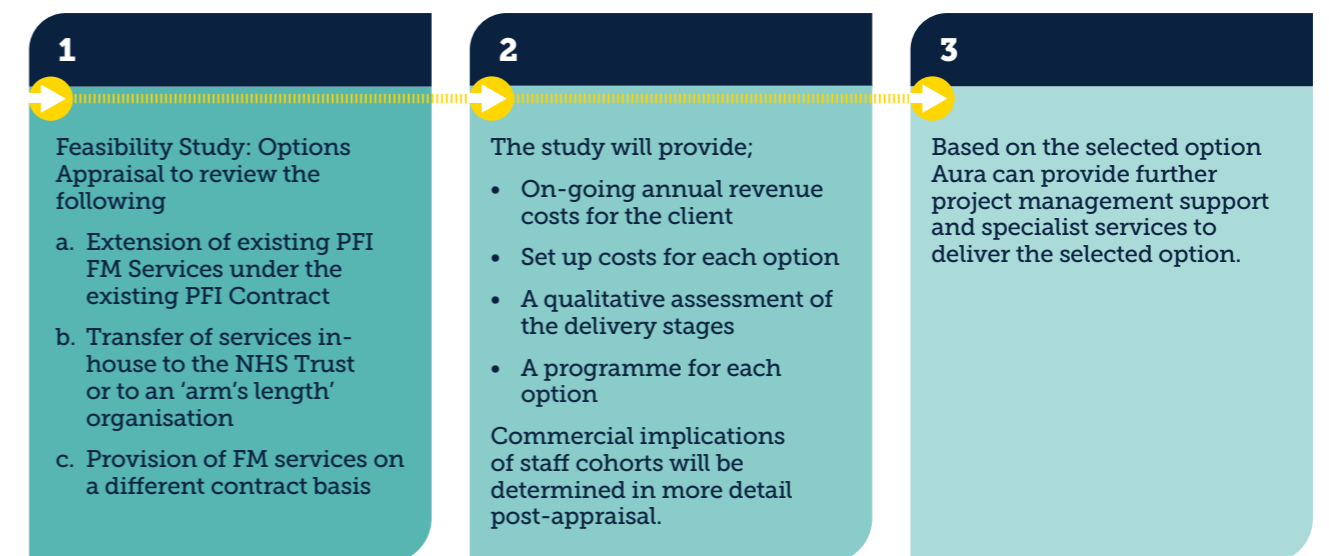


Aura's approach to managing the handback process is illustrated below. The service is managed by Aura Project Managers and we draw from our extensive supply chain to provide specialist services.
